Various Crestview area organizations, churches, businesses, and individuals donate their own time and materials (with most participants providing a game, activity, or vendor display in the downtown area along Main Street) that will help to create a carnival style atmosphere for enjoyment by all in attendance, especially the youngsters of our area. We request and encourage that free treats (candy, trinkets, etc.) be distributed at all participant sites so that youngsters may consider this event to be an alternative to "trick or treating". Participants with an activity (games, contests, face painting, etc.) should ensure the activity is appropriate for children and that participation is free of charge. Feel free to have information at your designated site to help promote your cause, your business, or your organization. You may have display banners, provide informational flyers, and pass out business cards.

With the exception indicated in the next sentence, there will be no charge for participation in this event.

If a Fall Festival participant (non-profit or for-profit) will be selling services or items (of any kind) at their activity/booth/vendor site, the MSCA will require that a \$50.00 fee payment\* be made at the time the participant registration form is submitted.

We need people such as you, your friends, organizations, churches, and businesses to make the Downtown Fall Festival a huge success. We encourage participation and ask that this form be completed and returned as soon as possible.

\*Any fee payments received by the MSCA will be used to support various Association and City of Crestview downtown revitalization efforts including promotional events, streetscape improvements, and other special projects. If the event is rained out, there will be no refunds for those selling participants required to pay a fee (the \$\$\$ will be considered as an MSCA support contribution) and there are no current plans for a rescheduled rain date.
