## **Crestview Fire Department Babysitter Program**

The Crestview Fire Department (CFD) Babysitter Program is an up-to-date and well-rounded youth development program. The program includes basic first aid training, CPR with AED training, car seat familiarization, and fire extinguisher training. Participants completing the program will receive an American Heart Association CPR card and a CFD issued qualification card that are both valid for two years..

Applicants must be at least 14 years of age. A fingerprint card and background check must be conducted by Crestview Police Department prior to acceptance and the fingerprints will be kept on file with CFD. Applicants must bring the fingerprint card, a program fee payment of \$50.00, and the completed application to CFD headquarters for admittance into the program. The duration of the program runs for approximately eight hours. Up to 15 applicants will be accepted, pending approval, and notification will be sent for the next available date that the program will be conducted.
